FAR NOTICE OF SECURITIES APPLICATION

The Florida Public Service Commission will consider at its October 1, 2024 Agenda Conference, Docket No. 20240122-EI, Application for authority to issue and sell securities during calendar years 2025 and 2026, pursuant to Section 366.04, F.S., and Chapter 25-8, F.A.C., by Florida Power & Light Company (FPL). FPL seeks Commission approval to (a) authorize FPL to issue and sell and/or exchange any combination of long-term debt and equity securities and/or to assume liabilities or obligations as guarantor, endorser or surety in an aggregate amount not to exceed \$8.6 billion during calendar year 2025; and (b) authorize FPL to issue and sell short-term securities in an amount or amounts such that the aggregate principal amount of short-term securities outstanding at the time of and including any such sale shall not exceed \$5.6 billion during calendar years 2025 and 2026.

DATE AND TIME: Tuesday, October 1, 2024. The Agenda Conference begins at 9:30 a.m., although the time at which this item will be heard cannot be determined at this time.

PURPOSE: To take final action in Docket No. 20240122-EI, Application for authority to issue and sell securities during calendar years 2025 and 2026, pursuant to Section 366.04, F.S., and Chapter 25-8, F.A.C., by Florida Power & Light Company.
