LITTLE GASPARILLA ISLAND PRESERVATION ALLIANCE, INC., PALM ISLAND ESTATES ASSOCIATION, INC., AND LINDA COTHERMAN'S AMENDED I JOINT MOTION FOR CONTINUANCE OF TESTIMONY AND EXHIBIT DEADLINE

Little Gasparilla Island Preservation Alliance, Inc., Palm Island Estates Association, Inc., and Linda Cotherman (collectively, "Movants"), through undersigned counsel and pursuant to Rule 28-106.210, Florida Administrative Code, and the Order Establishing Procedure dated August 12, 2024, file this request for a continuance of Movants' testimony and exhibit deadline, which is currently scheduled for October 18, 2024.

Rule 28-106.210, Florida Administrative Code, provides:

The presiding officer may grant a continuance of a hearing for good cause shown. Except in cases of emergency, requests for continuance must be made at least five days prior to the date noticed for the hearing.

On September 24, 2024, Charlotte County declared a local state of emergency due to then-Tropical Storm Helene. This declaration included an evacuation order for Charlotte County's barrier islands, including Little Gasparilla Island, where Movants (and their members) are located and were required to evacuate from. *See* Charlotte Cnty., *Charlotte County State of Emergency Declared, Evacuations Ordered*, https://www.charlottecountyfl.gov/news/charlotte-county-state-of-emergency-declared-evacuations-ordered.stml (Sept. 24, 2024). Tropical Storm Helene quickly developed into a Category 4 major hurricane, with an extreme threat of flooding for large portions of Florida's Gulf Coast, including Charlotte County's barrier islands. *See* Charlotte Cnty.,

Unfortunately, the risk of flooding came to fruition, with widespread flooding in Charlotte County, caused by an estimated storm surge of five to seven feet. See Charlotte Cnty., County Urges Residents to Stay Off All Roads, https://www.charlottecountyfl.gov/news/county-urges-residents-to-stay-off-all-roads.stml (Sept. 26, 2024); see also Fox 4, Manasota Key digs out from piles of sand left by Helene's storm surge, https://www.fox4now.com/north-port-englewood/manasota-key-digs-out-from-piles-of-sand-left-by-helenes-storm-surge (Sept. 30, 2024).

As a result, Movants (and their members) are left to recover from the devastating flooding caused by storm surge from Hurricane Helene. Impacts include but are not limited to: electricity and internet outages, limiting ability to do research or work on testimony; extensive property cleanup, including removal of sand from properties and disposal of damaged household items and flooded flooring and drywall; and damage assessments and insurance claims. Simply put, Movants and their experts on the island need time to recover from this historic flooding event and cannot focus the appropriate amount of effort on their pre-filed testimony and exhibits at this time. As such, Movants request a continuance of two weeks for the following deadlines, which do not impact the final hearing schedule. The requested continuances will not prejudice the Utility in this matter because Movants propose that their deadlines be continued for an equal amount of time to Movants' requested continuance.
