5	We are here before you today regarding a
6	staff-assisted rate case for a Class C
7	water/wastewater utility named St. Johns Rivers
8	Estates Utilities. Staff accepted that utility's
9	application for SARC inform January. Regulatory
10	assessment fees for St. Johns was due March 31st of
11	this year, but we haven't received payment.
12	In order for a utility to be eligible for a
13	SARC, it must be up-to-date with all regulatory
14	assessment fees, or be on a preapproved repayment
15	plan. Staff has made efforts to contact the
16	utility and get it into compliance but, thus far,
17	our efforts have been unsuccessful.
18	So because St. Johns has not paid its
19	regulatory assessment fees, it is now ineligible
20	for the SARC process, and we are asking the
21	Commission to deny its application on that basis.
22	Mr. Richards and I are available should any of
23	the Commissioners have questions.
