FAR NOTICE OF SECURITIES APPLICATION

The Florida Public Service Commission will consider at its November 5, 2024 Agenda Conference, Docket No. 20240138-EI, Application for authority to issue and sell securities during twelve months ending December 31, 2025 pursuant to Section 366.04, F.S., and Chapter 25-8, F.A.C., by Duke Energy Florida, LLC (“DEF”). DEF seeks Commission approval to (a) issue, sell, or otherwise incur during 2025 up to \$1,500,000,000 of any combination of equity securities and long-term debt securities and other long-term obligations (exclusive of bank loans issued under the Company’s long-term credit facilities as mentioned in the request); and (b) to issue, sell or otherwise incur during 2025 and 2026 up to \$2,000,000,000 outstanding at any time of short-term debt securities and other obligations, which amount shall be in addition to and in excess of the amount the Company is authorized to issue pursuant to Section 366.04, Florida Statutes, which permits the Company to issue short-term securities aggregating to not more than five percent of the par value of the Company’s other outstanding securities.

PURPOSE: To take final action in Docket No. 20240138-EI, Application for authority to issue and sell securities during twelve months ending December 31, 20245 pursuant to Section 366.04, F.S., and Chapter 25-8, F.A.C., by Duke Energy Florida, LLC (“DEF”).
