Good Morning Ms. Smith,

Staff is understanding of both the initial communication breakdown and the impacts of Hurricane Helene on your utility. We're sorry to hear about the damages your office received as a result of Helene. As we mentioned in our prior email, we can accommodate extensions to respond to our deficiency letter regarding your company's certification with the Commission in Docket No. 20240126. We understand that due to damage from the storm there may be difficulties in acquiring or recreating some records and/or a limited ability to access some resources needed to correct the deficiencies due to high demand.
