Mr. Kelley, you are recognized for a summary.

MR. KELLEY: Good morning, Commissioners,
Patrick Kelley with the Division of Economics.

Item 7 is a petition by Florida City Gas for approval of the safety access and facility enhancement program true-up and cost recovery factors for January through December 2025.

The surcharge recovers costs associated with the expedited relocation of certain existing gas mains and associated facilities from rear lot easements to the street front, as well as the replacement of certain plastic orange pipe.

The proposed fixed surcharge is \$4.66 per month for customers using less than 6,000 therms per year, and \$7.77 per month for customers using more than 6,000 therms per year.

Staff has reviewed the proposed true-up and 2025 cost recovery factors, and recommends that the Commission should approve the proposed petition.
