7	This is Seveni Guffey with the Division of
8	Economics.
9	Item 8 is Florida Public Utility Company's
10	petition seeking approval of its Gas Utility Access
11	and Replacement Directive, also known as the GUARD
12	program, cost recovery factors for year 2025.
13	The GUARD surcharge recovers costs associated
14	with replacing problematic distribution pipes and
15	facilities, as well as the relocation of mains and
16	services lines to enhance safety and accessibility
17	of FPUC's distribution system.
18	The residential customer on the RES-2 tariff
19	using 20 therms per month will have a monthly bill
20	impact of \$2.22. Staff believes the calculation of
21	FPUC's GUARD revenue requirement and surcharge for
22	each rate class are accurate, and staff recommends
23	approval of the proposed GUARD surcharges to be
24	effective from January 1st, 2025.
