Public Service Commissions Board Subject: Construction of Low-Pressure Central Sewer System on Little Gasparilla Island

January 28, 2025

Dear Commissioners and to Whom it may concern:

As a home owner on LGI we want to urge local authorities and decision-makers to consider the unique characteristics of Little Gasparilla Island before moving forward with any plans for a sewer system. The island is not just a place to live; it is a cherished sanctuary that offers respite from the fast-paced lifestyle found elsewhere. Its natural landscapes, wildlife, and pristine waters draw residents and visitors alike, and we must do everything in our power to keep it that way.

Our first issue is to keep the preservation of the island. Introducing a sewer system can lead to pollution and disrupt local ecosystems. There are many scientific studies that have found the installation of a sewer system to be harmful to the ecosystem. Lastly, our community is still healing from recent hurricanes. Many families are trying to rebuild their homes and lives after losing everything. Our focus should be on helping residents rebuild and improve infrastructure that is resilient to future storms rather than imposing new financial burdens. Investing in the community's recovery and resilience will foster a stronger, more united island.

We can all conclude that keeping the island free from a sewer system is essential for preserving its natural beauty, avoiding unpredictable costs, and supporting a community still recovering from hurricanes. Protecting the island means protecting its future. It is time to prioritize the environment and the well-being of residents over unnecessary developments. The island should remain as a sanctuary for us and our future families!
