Dear Mr. Rendell:

Staff has completed its initial review of your application and has determined LP Waterworks, Inc. (LP or Utility) is eligible for a staff-assisted rate case (SARC). The filing fee for this rate case is \$2,000 (\$1,000 for water and \$1,000 for wastewater) based on the capacity of the Utility's water and wastewater system as provided by 367.145(2), Florida Statutes and Rule 25-30.020(2)(f), Florida Administrative Code (F.A.C.). The Utility submitted a filing fee of \$500 to the Commission. The balance of the filing fee is due by **March 6, 2025**, which will be the official filing date for this rate case. **Pursuant to Rule 25-30.455(7), F.A.C., the Commission will deny the application if the utility does not remit the filing fee within 30 days after official acceptance.** Staff acknowledges receipt of the copy of your application being sent to the Highlands County Administrative as required by Section 367.091(2), F.S.
