**SECTION 63.71 APPLICATION OF AT&T**

AT&T<sup>1</sup> applies for authority under Section 214(a) of the Communications Act, as amended, 47 U.S.C. § 214, and Section 63.71 of the Federal Communications Commission's ("Commission") rules, 47 C.F.R. § 63.71, to grandfather certain legacy voice services in certain wire centers located in 18 states.

## INTRODUCTION

Through this application, AT&T seeks to grandfather certain VoIP services, called AT&T Phone Service and AT&T Phone for Business, where AT&T can only provide the services over copper (the “Affected Services”), in portions of certain wire centers located in 18 states (the “Affected Service Area”). On February 12, 2024, AT&T received streamlined approval to grandfather these same services in other wire centers located in six of the 18 states at issue here.<sup>2</sup> On April 1, 2024, AT&T received streamlined approval to grandfather the same services in another set of wire centers located in the same 18 states at issue here.<sup>3</sup> As with AT&T’s earlier applications, grandfathering these outdated services will benefit the public and serve as an important step toward meeting both AT&T’s and the Commission’s goals of advancing toward next-generation technologies that customers crave. Once the services are grandfathered, all current customers that have not already abandoned the Affected Services will be able to keep their current service.

The benefits of facilitating this transition in these specific wire centers are particularly pronounced given the extreme lack of demand for the Affected Services in the Affected Service Area. In fact, fewer than 1.9% of Living Units in the Affected Service Area subscribe to either

Affected Service.<sup>4</sup> In the last year, fewer than 0.06% of prospective customers in Living Units in the Affected Service Area placed new orders for AT&T Phone Service over copper, and between January 2024 and November 2024, fewer than 0.03% of prospective customers in Living Units in the Affected Service Area placed new orders for AT&T Phone for Business over copper. In the same approximate time frame, cancellations of subscriptions to the Affected Services exceeded new orders of the service by over 350%. Since 2023, the number of subscribers to AT&T Phone Service and AT&T Phone for Business over copper in the Affected Service Area has declined by 17% and 13%, respectively.

While grandfathered customers have the option of retaining the Affected Services, individuals and businesses in the Affected Service Area have many cost-effective alternatives to choose from as alternatives for the Affected Services. These options include AT&T's next-generation solutions — AT&T Phone – Advanced (“AP-A”) and AT&T Phone for Business – Advanced (“APB-A”) — which AT&T specifically designed as reliable and cost-effective alternatives to legacy voice services. AP-A and APB-A are broadly available throughout the Affected Service Area. AT&T highlighted AP-A and APB-A as key alternatives to the Affected Services in its previous grandfathering applications in other wire centers, which received streamlined approval.<sup>5</sup> In addition to AP-A and APB-A, there are many competitive voice offerings in the Affected Service Area offered over cable, fiber, fixed wireless, mobile wireless, and satellite technologies, which most customers have already selected in lieu of the Affected Services.

### **Date of Planned Service Grandfathering:**

Effective on or after **March 17, 2025**, pending regulatory approval, AT&T's Affected Services will be grandfathered and will no longer be available for purchase by new customers. All current customers will be able to keep their current service after that date.

### **Points of Geographic Areas of Service Affected:**

AT&T plans to grandfather the Affected Services in the Affected Service Area in sections of 18 states: Alabama, Arkansas, Florida, Georgia, Illinois, Indiana, Kentucky,

Louisiana, Michigan, Missouri, Mississippi, North Carolina, Ohio, Oklahoma, South Carolina, Tennessee, Texas, and Wisconsin. Exhibit 1 identifies the list of AT&T wire centers in each state that include any service areas that fall within the Affected Service Area.

**Brief Description of Type of Service Affected:**

AT&T plans to grandfather AT&T Phone Service and AT&T Phone for Business in the Affected Service Area where AT&T can only provide the service over copper. AT&T will continue to accept new orders for AT&T Phone Service and AT&T Phone for Business in areas of these wire centers where AT&T can deliver those services over fiber.

AT&T Phone Service is an enhanced voice communication service that converts voice communications into Internet Protocol (IP) packets that are carried over AT&T's IP network — *i.e.*, “voice over IP” or “VoIP.” AT&T Phone Service includes direct-dialed calling and certain calling and call management features, as well as additional or advanced features that may be offered at additional costs.

AT&T Phone for Business provides an enhanced voice communication service that converts voice communications into Internet Protocol (IP) packets that are carried over AT&T's IP network. It may be generically referred to as “voice over IP” or “VoIP.” The service includes direct-dialed calling and certain calling and call management features or advanced features associated with the service.

**Brief Description of the Dates and Method of Notice to All Affected Customers:**

Customer notices were sent via U.S. Mail on January 15, 2025 for Affected Customers of the Affected Services.<sup>6</sup> Copies of this Application are being sent via first class U.S. Mail to the

governor, public utility commission, federally recognized tribes (if any) in the Affected Service Area, and to the Special Assistant for Telecommunications to the Secretary of Defense, as required by 63.71(a) of the Commission's rules.<sup>7</sup>

**Regulatory Classification of Carrier:**

AT&T offers the Affected Services pursuant to non-dominant carrier regulation.

**Public Convenience and Necessity:**

The public convenience and necessity will not be impaired by the grandfathering of these services. The demand for the Affected Services is very low. The small base of existing customers for the Affected Services has been steadily eroding, and new customer orders for the Affected Services in the Affected Service Area are insubstantial. As noted above, fewer than 1.9% of Living Units in the Affected Service Area subscribe to either Affected Service. In more than 95% of the wire centers affected by this application, AT&T received *nine or fewer* new orders for AT&T Phone Service in the last year. Likewise, in more than 95% of the wire centers affected by this application, AT&T received *four or fewer* new orders for AT&T Phone for Business between January 2024 and November 2024. AT&T received *zero* new orders in the past year for AT&T Phone Service in over 23% of the wire centers affected by this

application, and *zero* new orders for AT&T Phone for Business in over 43% of the wire centers between January 2024 and November 2024. As a result, it is economically inefficient for AT&T to continue to make the Affected Services available for new customers. Once these services are grandfathered, all current customers will be able to keep their current services, but prospective customers will no longer be able to purchase them.

Prospective and current customers in the Affected Service Area have numerous options to choose from in lieu of the Affected Services. As evidenced by the data described above, most consumers have elected to receive voice services from the many alternative providers competing in the area. AT&T, T-Mobile, Verizon, and mobile resellers offer CMRS-based voice throughout the Affected Service Area.<sup>8</sup> Those who still use wired phones presumably are purchasing voice service from cable or fiber providers, such as Charter or Xfinity, among others. Customers in the Affected Service area also can purchase internet service through fixed wireless providers and use over-the-top VoIP services in conjunction with their wired (or cordless) telephones. Other customers still can use satellite providers, including Viasat, Hughes, and Starlink. All of these services are regularly advertised as cost-effective options for voice service.<sup>9</sup>

Most importantly, AT&T now offers AP-A and APB-A, which AT&T specifically designed as cost-effective alternatives to legacy voice services. AT&T has devoted substantial resources into developing AP-A and APB-A, which leverage AT&T's substantial investments in its wireless network to ensure that customers enjoy continued access to dependable and cost-effective voice services. These easy-to-use, competitively priced services are broadly available across the Affected Service Area and provide superior functionality than the Affected Services. Indeed, AT&T highlighted AP-A and APB-A as key alternatives to the Affected Services in its previous grandfathering applications in other wire centers, which received streamlined approval.<sup>10</sup> The Commission also recently recognized that AP-A is an adequate replacement for legacy voice services by approving streamlined treatment for AT&T's discontinuance application for AT&T Residential Local Service in certain wire centers in Oklahoma.<sup>11</sup> Between

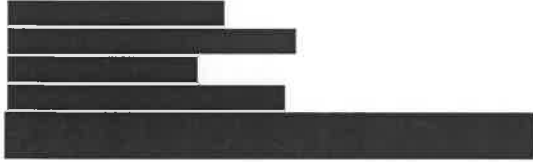
