16	2024, the Florida Public Service Commission
17	acknowledged that resolution.
18	Effective upon the adoption of the resolution,
19	all non-exempt water and wastewater systems in
20	Citrus County became subject to the provisions of
21	Chapter 367, Florida Statutes.
22	Staff recommends the application for a
23	grandfather certificate be approved, and the rates
24	and charges shown on Schedule 1 be approved.
