Dear Commissioners,

On behalf of AARP and our members within Florida Power & Light (FPL) service areas, we urge the Public Service Commission (PSC) to hold multiple public hearings regarding the proposed rate increase. To ensure broad accessibility, we recommend prioritizing hearings in densely populated service areas, where more ratepayers can participate and voice their concerns.

These hearings are essential for transparency and for allowing individuals from diverse backgrounds and financial situations to share how the rate changes could impact their daily lives. AARP is particularly concerned about the financial strain rising utility costs place on older residents, many of whom live on fixed incomes. Higher electricity rates disproportionately affect seniors, often forcing difficult choices between essential needs such as medication, food, and energy.

Given the significant number of AARP members within FPL's service area, it is critical that the PSC provides ample opportunities for public input. We appreciate your attention to this matter and strongly urge you to prioritize broad community participation.
