On February 26, 2025, Tampa Electric Company (TECO) filed a request for confidential treatment of Document No. 01157-2025. This document consists of a USB which contains the reports and analyses of Hurricanes Helene and Milton, which detail internal processes and decisions made in response to the Hurricanes. The order of de-energizing and restoration of circuits is also discussed.

In its request for confidentiality, TECO asserts that disclosure of this information would harm TECO, as the information relates to security measures and competitive interests. Furthermore, TECO states that the Company treats the highlighted information provided in Document No. 01157-2025 as private and has not publicly disclosed it.

Staff has review the document and concurs with TECO that the nature of the information meets the requirements set forth in Section 366.093(3)(c) and (e), Florida Statutes, whereby disclosure of the information would impair the security measures and competitive business interests of the provider of the information. Therefore, staff recommends the request by TECO for confidential classification of Document No. 01157-2025 be approve.
