ON STATUS OF TERRITORIAL AGREEMENT BETWEEN
TAMPA ELECTRIC COMPANY AND SUMTER ELECTRIC COOPERATIVE, INC.**

In Order No. PSC-94-1397-FOF-EU issued on November 16, 1994 in Docket No. 940947-EU the Commission approved the territorial agreement, entered into by and between Tampa Electric Company and the Sumter Electric Cooperative, Inc. Section 4.1 of said agreement calls for an annual report from Tampa Electric Company providing the status of the agreement and any modifications proposed in the agreement.

This is to advise the Commission that the subject territorial agreement remains in full force and effect and that a Joint Petition of Tampa Electric Company and Sumter Electric Cooperative, Inc. dated April 2, 2020 was submitted for Approval of Extension of Territorial Agreement and First Amendment to Territorial Agreement. The Joint Petition was approved by the Commission on July 24, 2020 in Order No. PSC-2020-0260-PAA-EU in Docket No. 20200116, as consummated by Order No. 20200282-CO-EU, issued August 20, 2020.


