Dear Mr. Teitzman:

On March 14, 2025, FPL provided notice that a greater than ten percent under-recovery was projected for the period ending December 31, 2025 based on actual data through February 2025 and NYMEX settlement prices for natural gas as of March 3, 2025. NYMEX settlement prices as of April 1, 2025 and the forward curve for the balance of the year again indicated that FPL would be under-recovered by greater than 10% for the period ending December 31, 2025. Since that time, however, the NYMEX forward curve for natural gas prices has decreased materially, largely due to uncertainty in future demand. Accordingly, FPL believes it is prudent to continue to defer a decision regarding whether to file a petition for mid-course correction to its filed 2025 fuel cost recovery factors. FPL will continue to monitor fuel cost data and will update the Commission in May.
