PETITION OF TAMPA ELECTRIC COMPANY

Tampa Electric Company ("Tampa Electric" or "the company"), hereby petitions the Commission for approval of the company's conservation cost recovery true-up for the period January 2024 through December 2024. In support thereof, the company says:

Conservation Cost Recovery

1. During the period January 2024 through December 2024, Tampa Electric incurred actual net conservation costs of \$47,812,471 plus a beginning true-up over-recovery of \$8,209,235 for a total of \$39,603,236. The adjusted net true-up amount for January 2024 through December 2024 was an over-recovery of \$3,649,409 including interest. (See Exhibit No. RGJ-1; Schedule CT1, Page 1 of 1 and CT2, Page 1 of 4, filed May 1, 2025).

2. Tampa Electric requests that the over-recovery be included in the calculation of its cost recovery factors for the period beginning January 2026. The company performed the calculation of the final net true-up for January 2024 through December 2024 consistently with prior true-up calculations approved by the Commission in prior Energy Conservation cost recovery dockets. This calculation is supported by the testimony of Tampa Electric witness Robert G. Johnston and Exhibit No. RGJ-1, entitled "Tampa Electric Company, Schedules Supporting Conservation Cost Recovery Factor, Actual, January 2024–December 2024".

3. Tampa Electric is not aware of any disputed issues of material fact relating to the matters addressed or the relief requested in this petition.

WHEREFORE, Tampa Electric Company requests the Commission's approval of the company's prior period conservation cost recovery true-up calculations for the period January 2024 through December 2024.
