8 Item No. 7 is staff's recommendation to  
9 suspend Florida Power & Light Company's proposed  
10 tariff sheets associated with its proposed  
11 demand-side management plan.

12 On March 18th, 2025, FPL filed its petition  
13 for approval of its DSM plan and program standards,  
14 which included modifications of and additions to  
15 its tariff sheets related to the existing  
16 Residential On-Call program and its associated HVAC  
17 On-Bill Pilot program.

18 Staff is recommending that FPL's proposed  
19 tariff sheets be suspended to allow sufficient time  
20 to review the utility's request. The 60-day  
21 statutory deadline for this action is May 17th,  
22 2025.

23 Staff is available for questions.
