9 Quail Heights provides water service to the  
10 Quail Heights Country Club in Lake City.

11 Wastewater service is provided by Lake City.

12 The utility was previously under the  
13 jurisdiction of the Columbia County Board of  
14 Commissioners, which passed a resolution in 2024,  
15 making privately owned water and wastewater  
16 companies in Columbia County subject to Chapter  
17 367, Florida Statutes. Quail Heights filed an  
18 application for a grandfather water certificate in  
19 2024 after the Commission acknowledged the  
20 resolution.

21 Staff recommends that the Commission approve  
22 Quail Heights' application for a grandfather water  
23 certificate. And staff is available for any  
24 questions you may have.
