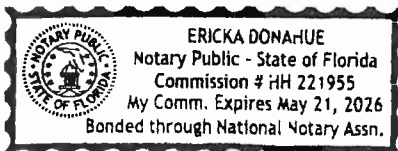

By Order No. PSC-2023-0192-PAA-WS, issued June 30, 2023, in Docket No. 20220185-WS, the Commission approved a limited alternative rate increase for Crestridge Utilities, LLC. (Crestridge or utility). The utility was required to hold any revenue increase granted subject to refund with interest in accordance with Rule 25-30.360(4), F.A.C. In order to ensure overearnings did not occur with the implementation of the rate increase, an earnings review of the 12-month period following the implementation of the revenue increase. Based on that review, it was determined that Crestridge was overearning. By Order No. PSC-2025-0181-PAA-WS, issued May 30, 2025, in the above-referenced docket, the Commission decreased the utility's rates and ordered a refund be made to customers. Credits to customer accounts are expected to be issued within the next 30 to 60 days. The decreased rates are set forth below.

The utility was required to hold any revenue increase granted subject to refund with interest in accordance with Rule 25-30.360(4), F.A.C. In order to ensure overearnings did not occur with the implementation of the rate increase, an earnings review of the 12-month period following the implementation of the revenue increase. Based on that review, it was determined that Lake Yale's wastewater system was overearning. By Order No. PSC-2025-0181-PAA-WS, issued May 30, 2025, in the above-referenced docket, the Commission decreased the utility's wastewater rates and ordered a refund be made to customers. In addition, the utility rates were reduced to remove amortized rate case expense from a prior rate case. Credits to customer accounts are expected to be issued within the next 30 to 60 days. The approved rates are set forth below.
