How Phil Murphy Caused New Jersey Electricity Prices to Soar WSJ

Despite flat electricity demand for the past two decades—and some of the lowest energy usage per capita among the 50 states—New Jersey residents pay some of the highest retail power prices in the country. As of April 2025, the Garden State ranked No. 12 in

the nation, with prices more than 15% above the U.S. average. This gap has widened further in the wake of the recent decision by the New Jersey Board of Public Utilities to approve an additional 17% to 20% rate increase for most utility customers starting in June.

A decade ago, the *outlook for New Jersey electricity prices was much brighter. The state was adding natural-gas generation capacity to take advantage of abundant, lowcost Marcellus Shale gas located next door in Pennsylvania.* By 2016, New Jersey achieved energy independence by supplying all its power needs with in-state generation for the first time in its history, partially fueled by Pennsylvania gas. *Then the state threw it all away. Since electing Gov. Phil Murphy in November 2017, New Jersey has shut down all its coal plants, reduced its natural gas-generation capacity, and increased its reliance on intermittent wind and solar power. Trenton is on a quixotic quest to achieve 100% “clean” electricity production by 2035.*

Under Mr. Murphy’s leadership, New Jersey has tilted at offshore windmills—none of which have been completed to date, mainly due to cost overruns, despite the state’s generous financial incentives. *New Jersey has also subsidized the rollout of solar power (mostly nonutility scale) even though the state experiences only 94 days with less than 30% cloud cover in an average year.* The state ranks seventh in the country for small-scale solar power generation, with rooftop and utility-pole solar panels now ubiquitous.

Such supply-side mismanagement has led to a 12% decrease in New Jersey’s electric-generating capacity since 2016. Over the same period, average residential power prices increased by almost a third even as consumption declined slightly. The shale revolution has led to a significant drop in U.S. natural-gas prices since the 2000s, but New Jersey electricity customers have seen no benefit in their monthly bills.

A growing dependence on out-ofstate generation to meet electricity demand—the shortfall stood at 16% in 2024—has increased the state’s reliance on the Pennsylvania-New Jersey-Maryland, or PJM, regional transmission organization. This subjects New Jersey to even harsher climate policy.

PJM was started as a two-state, three-utility power pool in 1927 but has expanded into one of the largest regional grid operators in the U.S., responsible for balancing electricity supply and demand across 13 states plus the District of Columbia. Given

PJM's largely blue-state makeup, it's no surprise that its leadership has let climate policy objectives overrun grid planning and market dynamics in recent years.

Despite annual capacity pricing auctions meant to create an incentive for the construction of new power plants, total committed daily PJM capacity decreased by roughly 20%, or 34.3 gigawatts, between June 2015 and June 2025. Like Trenton, PJM has replaced dispatchable coal and natural-gas generation with variable wind and solar facilities across its entire service territory. Subsequent

The state was energyindependent in 2016, thanks to Pennsylvania shale gas. No longer.

interconnection bottlenecks have delayed many winningbid renewable projects as PJM struggles to provide the necessary new transmission infrastructure quickly enough. ***Both the North American Electric Reliability Corp. and the Energy Department have raised concerns about grid reliability and potential outages in the PJM system over the next five years due to the forecast increase in electricity demand from data centers and other large industrial users.***

The laws of energy supply and demand are catching up with PJM— and New Jersey. In its last regular capacity auction, generation prices went up more than ninefold yearover- year. It was this price spike that led to the recent regulator-approved 17% to 20% increase in New Jersey residential bills.

Rather than ***mailing out government checks to provide temporary ratepayer relief as the Murphy administration has recently done, New Jersey needs to take responsibility for its own energy destiny by returning to energy self-sufficiently.*** This would make it no longer necessary to participate in PJM. Despite Trenton's climate delusions, from a reliability, cost and emissions perspective, New Jersey already has an optimal generation mix. **Natural gas and nuclear currently comprise more than 90% of its electricity output.** ***The Garden State just needs to supersize both fuel sources to catch up with current demand as well as projected load growth.***

New natural-gas combined-cycle plants can be delivered within three years and are the most affordable option. More natural gas power will also allow New Jerseyites finally to receive the shale dividend that they were promised years ago. Largescale nuclear reactors take longer to complete but never go dark during their 80-year operating lives. **New Jersey should take advantage of the Trump administration's push to quadruple domestic nuclear capacity by 2050.**

In a hopeful sign earlier this year, the state's public utilities board sent out a request for information on potentially building new nuclear power plants in the state.

*Bringing down New Jersey's skyhigh electricity prices will require a fundamental shift in the political outlook in Trenton. **Sound energy policy is on the ballot in the Garden State in November.***

I am writing to address the recent application of FPL for rate increases for years 2025-2029 docket #20250011. FPL is due a fair profit on their service, however as an essential service to Florida residents, it should not be excessive. These increases appear excessive and put additional burdens on folks like me. In particular it is the increase in the minimum base bill to \$30 and its *application* to solar customers like me I understand the need for a minimum base bill and do not object to the practice.

I understand that I currently must use at least 220 kwh per billing period and if not, be subject to a \$25 minimum charge even though the charge for my actual usage would be less than \$25. It's how it is applied to solar system customers that seems unfair.

In my most recent bill, my actual usage for the period Jun 18 - Jul 18 was 378 kwh. My solar system generated 338 excess kwh during the same period which were credited to my reserve.

The billing algorithm credits me with 378 kwh from my reserve netting me a charge of zero hours.

Since there is a minimum charge of \$25.00 (equivalent to 220 kwh) and I have net zero hours after reserve credits, I am being billed the \$25.00 minimum.

I am being charged \$25.00 **AND** 220 kwh from my reserve. That 378 kwh credit **INCLUDES** my 220 kwh minimum! So, I have paid my minimum in kwh generated. I should not be billed an additional \$25.

As a solar customer, I am effectively paying the minimum twice, in both cash and kwh!

Please address this billing practice to stop FPL from effectively double billing solar customers for the minimum base bill. If I am in error in my analysis, please explain to me how this is not true and this billing practice is fair.

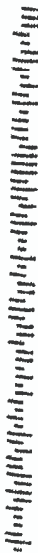

I'm writing to urge you to reject Florida Power & Light Company's proposed rate increase (Docket No. 20250011).

FPL is requesting nearly \$10 billion in new charges over the next four years — costs that will fall on the backs of the very people who rely on FPL to keep the lights on. Half of every dollar in this proposal would go straight to shareholder profits, not essential services. That's unacceptable.

In the last five years alone, FPL customers have seen their bills jump by more than \$400 a year. This latest plan would add another \$360 in just two years – all while Floridians are still recovering from devastating storms and battling the rising cost of living.

FPL claims the hike is needed to meet demand, but the Office of Public Counsel has made it clear that this is misleading. According to OPC, FPL's numbers are inflated — and rather than raise rates, the company should actually cut them by \$620.5 million in 2026.

Regarding Docket 20250011-EI (FPL Rate Increase).

I oppose Florida Power & Light's proposed base rate increase and any settlement that raises customer bills.

Why:

- Monopoly and accountability. FPL is a state-sanctioned monopoly with an exclusive service territory. Because customers cannot choose another provider, the Commission should apply the highest prudence standards and deny recovery of imprudent costs or outsized returns.
- Business choices vs. necessities. Much of the current multi-year plan reflects FPL’s own investment strategy and profit targets. Ratepayers should not be compelled to guarantee higher earnings or prepay projects that do not measurably improve reliability or customer service.
- Solar and battery costs and reliability. FPL plans to pass along costs for large solar and battery projects in later years. Today’s batteries are short duration and cannot meet overnight or multi-hour peak demand. Please require evidence of firm, dispatchable capacity and proven reliability benefits before allowing cost recovery.
- Solar farm incident cost allocation. After the recent Kayak Solar Energy Center breach in Holt, described publicly as a “catastrophic failure” that discharged sediment into wetlands and onto residential properties, any remediation or legal costs should be borne by shareholders, not customers.
- Customer care and participation. Affordability and service remain top concerns. Please require measurable customer-service performance improvements, including response times and complaint resolution, and prioritize bill impacts for households on fixed incomes.

Requested actions:

1. Reject or substantially reduce the base rate increase.
2. Lower the allowed ROE and disallow recovery of costs tied to imprudent projects or incidents.
3. Condition any approval on verifiable reliability improvements, including adequate firm capacity and storm hardening.
4. Adopt clear customer-service metrics before any increase takes effect.
