As you can see, it appears that the description contains 15 Calls. However, based on the map provided, it appears there should be 16 calls (see attached). We were unable to find the call which is represented by the asterisk on the sketch below the territory map. If that call could be added to the existing description, it should resolve this issue. Additionally, please remove the references to Plat Books in the territory description. That reference isn't need since we have the longitude and latitude points, and it goes against our Rule.
