6	Economics.
7	Item 6 is a petition from Florida Public
8	Utilities Company requesting approval of swing
9	service rider rates for January through December
10	2026. The swing service rider allocates a portion
11	of the company's intrastate natural gas pipeline
12	capacity costs to transportation customers.
13	The total intrastate capacity costs reflect
14	payments by FPUC to intrastate pipelines for the
15	transportation of natural gas. The swing service
16	rider rate is a cents per therm charge that is
17	calculated and included in the monthly bill for
18	transportation customers. Staff has reviewed the
19	proposed rates and believes that they have been
20	calculated according to the original order
21	approving the swing service tariff.
22	Based on staff's review of FPUC's responses
23	and petition, staff recommends that the Commission
24	should approve FPUC's proposed swing service rider
25	rates to be effective for the period January
