5	Oakley Ward with the Division of Economics.
6	Item 5 is a petition by Peoples Gas System,
7	Inc., for approval of the 2024 true-up, projected
8	2025 true-up, and 2026 revenue requirements and
9	surcharges associated with the cast iron/bare steel
10	pipe replacement rider.
11	Peoples was originally scheduled to complete
12	the cast iron/bare steel pipe replacements in 2022,
13	but explained that it experienced delays. Peoples
14	stated that it expects to have approximately 2.4
15	miles of cast iron/bare steel replacement remaining
16	entering 2026. The replacement of problematic
17	plastic pipeline is expected to continue until
18	2028. The proposed surcharge will have a monthly
19	bill impact of 32 cents for a residential customer
20	who uses 20 therms.
21	Staff recommends approval of the proposed
22	surcharges to be effective January 1st, 2026.
