5	Commissioners. Seveni Guffey with the Division of
6	Economics.
7	Item 6 is Florida Public Utilities Company's
8	petition seeking approval of its gas utility access
9	and replacement directive cost recovery factors for
10	year 2026. The program is also called the GUARD
11	program.
12	The GUARD surcharge recovers costs associated
13	with replacing problematic distribution pipes and
14	facilities, as well as the relocation of mains and
15	service lines to enhance safety and accessibility
16	of its distribution system.
17	The residential customer on the RES-2 tariff
18	using 20 therms per month will have a bill impact
19	of \$5.20. Staff believes the calculation of FPUC's
20	GUARD revenue requirement and surcharges for each
21	rate class are accurate, and, therefore, staff
22	recommends approval of the proposed GUARD
23	surcharges to be effective from January 1st, 2026.
