Citrus Waterworks, Inc. (Citrus) hereby submits its response to Staff's Deficiency Letter dated December 16, 2025. Attached are the revised existing service territory, revised existing map, and revised proposed customer notice. The territory description and map are consistent with the territory that was being served when the utility was acquired as evidenced on the map from the engineering firm in 1999 supplied in Document No. 15534-2025 filed on December 23, 2025 in this docket. These existing customers were being served from at least 1999 or longer. Citrus Waterworks was unaware that the territory approved in Order No. PSC-2025-0041-PAA-WU, issued February 6, 2025 was incorrect.

Once the proposed customer notice is approved by the Commission Staff, Citrus will send the notice to the customers and publish it in the appropriate local newspaper. The appropriate proof of noticing and affidavits of noticing will be provided as late-filed exhibits.
