4 will move to Item No. 1. I believe, Ms. Guffey,  
5 you will be presenting the item.

6 MS. GUFFEY: Thank you. Good morning,  
7 Commissioners. This is Seveni Guffey with the  
8 Division of Economics.

9 Item 1 is Florida Public Utility Company's  
10 petition to implement a base rate increase which  
11 the Commission approved in FPUC's 2025 Stipulation  
12 and Settlement Agreement. The settlement deferred  
13 the collection of dollars one million until March  
14 2026. In this petition, consistent with the  
15 settlement, FPUC seeks to collect the deferred  
16 amount beginning in March 2026.

17 This recommendation is to suspend the proposed  
18 tariffs, as staff needs additional time to gather  
19 pertinent information in order to present the  
20 Commission with an informed recommendation of the  
21 tariff proposal. Staff will provide a final  
22 recommendation on the proposed tariffs at the March  
23 Agenda, with the tariff effective date of March  
24 20th, 2026.

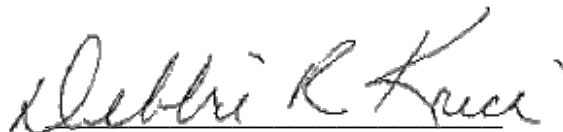
