I am a resident of Water Oak Country Club Estates in Lady Lake, FL, This community is owned by Sun Communities, Inc. This community is also a 55plus community, meaning that many of us are living on fixed income. Many living on Social Security ALONE!!!!

This year Social Security had a 2.8% increase. Sun Communities has raised my lot rent this year by 5% and now they want to raise our water an astronomical amount. Some have even said it was over a 300% increase. I oppose this attempt to raise these water bills.

This is causing many homeowners in our community to have to sell their homes in order to survive their financial woes. This is a very cruel way to treat the elderly community. If you include all the other prices that are increasing, such as groceries, we will not be able to continue to live here.



I implore you to deny this request to continue to gouge our homeowners. These increases would IMPOSE a HARDSHIP upon me and all our homeowners. We have approximately 1200 homeowners in this community. I beg of you to please deny this request and ask that this letter count as a formal, written objection to this proposed increase.

GROUND TO PROTEST:

Undue financial Burden: An increase of this magnitude is not sustainable particularly given that I am a fixed-income household. This company has not given sufficient evidence that the infrastructure improvements or costs justify an increase .
