My data and comments all relate to the data available in the online "2024 Annual Report" submitted to the Public Service Commission by Sun Communities and the "December 22, 2025 Staff Report" which was made available to the residents from a letter I received on January 13, 2026 from Water Oak Country Club Estates (can verify this delivery date with my USPS Informed Delivery daily email). Although the letter I received was dated January 7, 2026, I did not receive it 14 days in advance of the meeting, so they were non-compliant with providing the meeting notification and these details as required by the State of Florida 25-30.030 (7) which gave residents a minimal timeframe to review and comment on the proposed rate change.
