**STATUS REPORT**  
**Docket No. 20220185-WS**  
**January 20, 2026**

PSC-2025-0181-PAA-WS, issued May 5, 2025, required refunds of overearnings for Crestridge Utilities, LLC, East Marion Utilities, LLC, and, Lake Yale Utilities, LLC, based on staff's earnings review of a Limited Alternative Rate Increase that was approved in Docket No. 20220185-WS. A summary of the status for the refunds with revisions to prior status reports are provided below.

**Crestridge Utilities, LLC (CRU)**

On September 20, 2025, CRU reported that 175 former customers were due LARI refunds and interest totaling \$6,838. CRU determined that 51 of the 175 former customer accounts, totaling \$2,418, showed an outstanding credit balance that exceeded the total refund amount. CRU posted the refund against the outstanding balance for each former customer's account. On August 27, 2025, CRU delivered (via US Mail) 124 refund checks with interest, totaling \$4,420, to their former customers at their last known address on file. As of, January 20, 2026, the status of the former customer account refunds are displayed below.

**Lake Yale Utilities, LLC (LYU)**

On August 20, 2025 LYU reported the following customer refund counts and totals. Included within the table below are revisions due to 3 customers moving out subsequent to our initial calculations and the refund posting date of August 15, 2025.

On September 20, 2025, LYU reported that 41 former customers were due LARI refunds and interest totaling \$2,861. Those numbers have been revised to reflect 44 customers with refunds totaling \$3,415. LYU subsequently determined that 2 of the 44 former customer accounts, totaling \$22, showed an outstanding credit balance that exceeded the total refund amount. LYU posted the refund against the outstanding balance for each former customer's account. On August 27, 2025, LYU delivered (via US Mail) 42 refund checks with interest, totaling \$3,393, to their former customers at their last known address on file. No outstanding checks have cleared the bank since the December 20, 2025, summary report. As of, January 20, 2026, the status of the former customer account refunds are displayed below.
