Pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company ("FPL") requests confidential classification of certain information sent in response to the Office of Public Counsel's ("OPC") 17th request for production of documents ("POD"). More specifically, the information which confidentiality is sought relates to POD No. 142.

According to FPL, the confidential information contains information concerning contractual pricing data, the disclosure of which would impair the efforts of FPL to contract for goods or services on favorable terms to the detriment of FPL's customers. Specifically, the information contains negotiated capacity and energy prices.

Staff has reviewed FPL's confidentiality request and agrees that the nature of the information meets the requirements set forth in Section 366.093(3)(d), F.S. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 04274-2025 be approved.
