(“Peoples” or the “company”) through undersigned counsel, and pursuant to the requirements in this docket, hereby petitions the Florida Public Service Commission (“Commission”) for approval of its purchased gas adjustment true-up amount for the period January 1 through December 31, 2025, and in support thereof says:

1. Peoples submits for filing with this petition the testimony of Matthew E. Elliott and Exhibit (MEE-1), consisting of Schedule A-7 of the purchased gas adjustment true-up reporting form supplied by the Commission Staff in accordance with the requirements in this docket.

2. As indicated in the testimony of Mr. Elliott and in Schedule A-7, Peoples’ final true-up amount for the period January 1 through December 31, 2025, including interest and adjustment, net of the estimated true-up for the same period, is an over-recovery of \$4,252,052.
