In 2019, the City of Lake Worth held a referendum regarding an official name change from the City of Lake Worth to the City of Lake Worth Beach. The referendum was approved by voters, with 51.12% voting in favor of the name change.

Following certification of the election results, the City Commission formally adopted Resolution No. 07-2019 on March 19, 2019, accepting the referendum results and officially recognizing the municipality's new name as the City of Lake Worth Beach.

Accordingly, the City of Lake Worth Beach Utilities respectfully request that the Florida Public Service Commission update its records and registration to reflect the name change of our utilities from City of Lake Worth Utilities to City of Lake Worth Beach Utilities, effective March 19, 2019.


