Pursuant to Section 367.0822, Florida Statutes, and Rule 25-30.445, Florida Administrative Code, Applicant, K W RESORT UTILITIES CORP. ("KWRU" or the "Company"), files this Application for a limited proceeding to increase its base rates and charges by \$525,677 annually to reflect cost recovery for increases in expenses in Monroe County, Florida, and states:

INTRODUCTION

Pursuant to Rule 25-22.0407(2), Florida Administrative Code, the Utility is simultaneously herewith mailing a copy of this Application to the chief executive officer of the City of Key West and Monroe County.

- (e) The Statement of Christopher A. Johnson, the President of the Utility, that the Utility will comply with the noticing requirements of Rule 25-22.0407, F.A.C., is attached hereto as **Exhibit A**.

2. In accordance with Rules 25-30.020(2)(g) and 25-30.445(3), Florida Administrative Code, a filing fee of \$2,250.00 is being filed contemporaneously with this Application.

MINIMUM FILING REQUIREMENTS

3. KWRU makes this Application for Limited Proceeding to increase its charges by \$525,677.00 annually to reflect increases in operating expenses in the amount of \$502,021.00 in Monroe County, Florida that continue the ability of KWRU to provide safe, reliable, and environmentally sound wastewater treatment services to its customers in accordance with applicable rules.
4. This Application for a Limited Proceeding is being requested, in part, to recover costs required by governmental or regulatory order. (See Fla. Admin. R. 62.600.720(d)).
5. **Exhibit B** to this Application includes the following information required by Rule 25-30.445:
 - (a) A schedule providing the specific rate base components for which the utility seeks recovery and supporting detail (Schedule 8 (Paragraph (4)(c) of the Rule));
 - (b) A schedule of accumulated depreciation and depreciation expense by NARUC account. (Schedule 9 (Paragraph (4)(d) of the Rule)). The calculation of the weighted average cost of capital used to calculate the revenue increase requested in this Application (Schedule -10 (Paragraph (4)(e) of the Rule));
 - (c) A schedule providing the specific operating expenses for which the utility seeks recovery and supporting detail (Schedule 4 (Paragraph (4)(f) of the Rule));
 - (d) The calculation of the annual revenue increase requested in this Application (Schedule 3 (Paragraph (4)(i) of the Rule));

- (e) The annualized revenues for the most recent 12-month period and a schedule reflecting this calculation by customer class and meter size (Schedule 7 (Paragraph (4)(j) of the Rule));

6. A schedule for the most recent 12-month period showing that, without any increased rates, the utility will earn below its authorized rate of return. (Schedule 11 ((Paragraph (4)(1) of the Rule). The Company is not requesting a change in the current rate structure via this Application.

In accordance with Rule 25-30.445(7), the Company states that, due to the operating expense increase requested in this Application, it does not identify rate base decline or expense recovery in this Application that will be offset by future customer growth associated with the KWRU system within one year of the date new rates are implemented.

8. This Application represents an original pleading. The Company is not responding to any proposed agency action.
9. KWRU is entitled to the relief requested pursuant to Chapters 367 and 120, Florida Statutes.

WHEREFORE, KWRU respectfully requests that the Commission enter a final order Granting an increase in wastewater rates consistent with the attached Exhibits for the recovery of costs associated with the KWRU Project; and Granting such other and further relief as the

Commission may find to be reasonable and proper pursuant to its authority under Chapter 367, Florida Statutes.

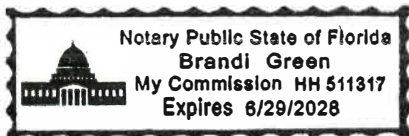

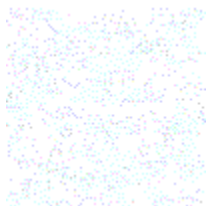
