2 CHAIRMAN CLARK: All right. We are going to
3 take up Item No. 4 through 6 together.

4 Mr. Willis.

5 MR. WILLIS: Good morning, Commissioners. My
6 name is Connor Willis from the Division of
7 Engineering.

8 Items 4 through 6 have petitions of approval
9 for the 2026 standard offer contracts for Duke
10 Energy Florida, Tampa Electric Company and Florida
11 Power & Light Company respectively.

12 Commission Rule 25-17.250, FAC, requires each
13 investor-owned utility to continuously offer to
14 purchase power from renewable generating facilities
15 and small qualifying facilities based on the next
16 avoidable fossil fuel generating unit of each
17 technology type identified in the utility's current
18 ten-year site plan.

19 The next avoidable units for Duke Energy
20 Florida, Tampa Energy Company and Florida Power &
21 Light, based on the 2026 ten-year site planes are
22 all natural gas-fired combustion turbines with
23 in-service dates of 2034, 2031 and 2032
24 respectively.

25 After reviewing each of the filings, staff

1 believes that the utilities' next avoidable units
2 are consistent with the appropriate rules and
3 statutes, therefore, staff recommends approval of
4 the amended standard offer contracts and rate
5 schedules for all three items.

6 Thank you.

7 CHAIRMAN CLARK: Thank you, Mr. Willis.

11 items.
