DESCRIPTION: FPL (Cox) - (CONFIDENTIAL) Certain information related to Andytown-Oasis need determination; specifically, information contained in Exhs MAY-2 and MAY-4 of [direct] testimony of Miguel Yanes; Attachment Nos. 4, 7, and 9, and Appendices A, B, and C (load flow diagrams) to Exh A of petition.

On March 11, 2026, Florida Power & Light Company (FPL or Utility) filed a request for confidential treatment of Document No. 01501-2026. This document contains portions of Exhibit A to the Utility's petition for the determination of need for the Andytown-Oasis Transmission Line Project, and two Exhibits to FPL witness Miguel Yanes' testimony. Specifically, it contains the following:

- Exhibit A, which contains descriptions of contingency analysis results;
- Attachment 4, which are line diagrams of FPL's transmission system;
- Attachment 7, which contains results of contingency analyses;
- Attachment 9, which is interconnection information associated with a nuclear facility;
- Appendices A-C, which are load flow diagrams of FPL's transmission system;
- Exhibit MAY-2, which contain line diagrams of FPL's transmission system, identical to a portion of Attachment 4; and
- Exhibit MAY-4, which contain results of contingency analyses.

FPL contends that the information constitutes proprietary and confidential business information entitled to protection under Section 366.093(3)(c), Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code. FPL asserts that the information at issue relates to security measures, systems, or procedures.

Staff has reviewed FPL's confidentiality request. For Exhibit A, Attachment 4, Attachment 9, and Exhibit MAY-2, staff concurs with FPL that the nature of the information meets the requirements set forth by Section 366.093(3)(c), F.S., whereby disclosure of the information

would result in harm to the Utility's assets and thus its ability to serve ratepayers. Therefore, staff recommends the request by FPL for confidential classification of these portions of Document No. 01501-2026 be approved.

The remaining three subparts, Attachment 7, Appendices A–C, and Exhibit MAY-4 each contain some material that falls within the bounds of proprietary confidential business information. For Attachment 7, this includes only rows 4 through 7 of the first table, the text contained in the first two rows of the space between the tables, and rows 4 through 24 of the second table. For Appendices A–C, this includes bates stamp pages FPL 000069 through FPL 000104. For Exhibit MAY-4, this includes the information in rows 3 through 8. Release of this information could result in harm to the Utility's assets and thus its ability to serve ratepayers. Therefore, staff recommends that confidentiality of Document No. 01501-2026 be granted for Attachment 7, Appendices A–C, and Exhibit MAY-4 in relation to the specific portions described above only. However, it is unclear how disclosure of the remaining information contained in the document would result in harm to FPL's assets. Thus, confidential classification of the remaining information is unwarranted.
