2	CHAIRMAN CLARK: All right. If everybody will
3	grab a seat, we'll go ahead and get started. We're
4	going to begin with our legislative update.
5	Ms. Pennington, Mr. Potts, who's going to head
6	that up?
7	Mr. Potts.
8	MR. POTTS: Hi. So, today is the 50th day of
9	the 2020 session. So, it's the last day in the
10	Senate for regularly-scheduled committee meetings.
11	With the budget right now, nothing has
12	changed, and we look good, as it is. Allocations
13	are not out yet. And it looks like conference will
14	probably start on Thursday, at the earliest.
15	Once conference finishes, there has to be a
16	72-hour cooling-off period before the budget can be
17	voted on. So, the budget needs to be the
18	conference needs to be done by Tuesday night to
19	have sine die on Friday night.
20	I was just going to go over a couple of the
21	bills that we're watching that's still alive.
22	Senate Bill 7018 and House Bill 7099 are essential
23	state infrastructure. Those are the two EV-plan
24	bills.
25	The Senate bill is the one that has the PSC as

1	the lead for the plan, and the House bill has DOT.
2	Both those bills are ready for the floor. And,
3	actually, the Senate bill is on special order for
4	tomorrow.
5	House Bill 207 and Senate Bill 658 are the
6	acquisition of water and wastewater systems. The
7	House bill is ready for the floor, and the Senate
8	bill is stuck in its second committee. So, they're
9	going to have to do some maneuvering for that one
10	to get to the floor and the Senate.
11	Senate Bill 998 and House Bill 1339 those
12	are housing bills. Our interest in those is that
13	there is language on the tenant/lot-owner issue for
14	mobile home parks that is in there that would do
15	would do sort of a fix for us. So, those bills
16	the Senate bill is up in appropriations this
17	afternoon, and the House bill is ready for the
18	floor.
19	Finally, Senate Bill 1464 and House Bill 1095,
20	the underground-facility damage-prevention bills
21	those are the 811s both of those are ready for
22	the floor in their irrespective chambers.
23	So, we're ten days left and seem to be
24	everything is going fairly well. So, we'll let you
25	know if any issues arise. And if you have any

1	questions or concerns, you can have our your
2	advisers get with us and we're happy to meet any
3	time.
4	CHAIRMAN CLARK: Commissioner Graham.
5	COMMISSIONER GRAHAM: Does it look like
6	they're going to end on time?
7	MR. POTTS: They are at the point right now
8	where I was just looking at Twitter. Everybody
9	is saying, oh, well, it looks like there might be
10	an extension. They're at the point where they're
11	trying to threaten staying longer. I'm not sure.
12	There's one other issue going on that that
13	might cause them to stay, but that just is so they
14	can keep their subpoena power. I think they
15	probably finish on time, would be my guess, but now
16	is when you start hearing everything.
17	CHAIRMAN CLARK: All right. Any other
18	questions for Mr. Potts?
19	Thank you, sir.
20	MR. POTTS: All right. Thank you.
21	CHAIRMAN CLARK: All right. Mr. Hetrick.
22	MR. HETRICK: Mr. Chair, I have no report.
23	CHAIRMAN CLARK: Thank you very much.
24	Mr. Baez.
25	Mr. Baez, welcome to the Florida Public

1	Service Commission.
2	MR. BAEZ: (Indicating.)
3	COMMISSIONER GRAHAM: (Inaudible.)
4	CHAIRMAN CLARK: He's waving in support is
5	that what you said?
6	(Laughter.)
7	MR. BAEZ: I I only have an apology to
8	offer at this point, Mr. Chairman. I'm sorry. We
9	don't we don't have a report today.
10	CHAIRMAN CLARK: All right. No problem.
11	All right. Any other matters to come before
12	the Commission?
13	COMMISSIONER POLMANN: I have one.
14	CHAIRMAN CLARK: Commissioner Polmann.
15	COMMISSIONER POLMANN: Thank you,
16	Mr. Chairman. We heard, in our agenda conference
17	today, a couple of references to our utilities,
18	water utilities, working with or intending to work
19	with the Florida Rural Water Association.
20	I know it's been a while, perhaps as far back
21	as 2015, since we've had a presentation at this
22	meeting from from that group. I would like to
23	suggest and invite the Commission to hear from that
24	organization, FRWA.
25	And if it's the pleasure of the Commission,

1	perhaps our staff can reach out to them and ask
2	them, at an appropriate meeting, to come and give
3	us a presentation and let us know the services that
4	they offer.
5	I, personally, would would like to know a
6	little bit more about the types of things they
7	they do. We make reference to that group on
8	occasion at our agenda conferences. So, maybe I
9	can have my people get with your people
10	CHAIRMAN CLARK: Absolutely.
11	COMMISSIONER POLMANN: get that on the
12	agenda at an appropriate moment, Mr. Chairman.
13	CHAIRMAN CLARK: I believe Director Baez has a
14	comment in that regard.
15	MR. BAEZ: We we'd be happy to facilitate
16	that. We've had the Rural Water Association in at
17	least a couple of times that I can recall
18	immediately. And we'd be happy to do it again.
19	And they're always happy to come down and talk to
20	us. So, we'll try and work the best date available
21	for for y'all the best IA available.
22	COMMISSIONER POLMANN: Yeah, I think I
23	think it may have been five years. I know
24	several
25	MR. BAEZ: Has it been that long?

1	COMMISSIONER POLMANN: Several of us have not
2	met with them.
3	MR. BAEZ: Yes. That I think there's a
4	majority on the Commission now that haven't had the
5	pleasure of the FRWA.
6	COMMISSIONER BROWN: (Inaudible.)
7	MR. BAEZ: Yes, he was a member of the task
8	force. They're they're an active association,
9	so
10	COMMISSIONER POLMANN: Thank you.
11	MR. BAEZ: We'll take care of it.
12	CHAIRMAN CLARK: Great. Thank you,
13	Commissioner Polmann.
14	I would also like to remind each of you that
15	my staff will be reaching out to you regarding
16	programs for IA over the next year. That's one of
17	the things that we do want to do is to have a
18	Commissioner-sponsored program in terms of an
19	information or update item every month. So, we'll
20	be getting in touch with you over the next month to
21	make sure those happen.
22	Commissioner Brown.
23	COMMISSIONER BROWN: So, this could be my
24	item.
25	CHAIRMAN CLARK: It's your item.

1	COMMISSIONER BROWN: This past week, I was
2	part of the NARUC delegation that went to Puerto
3	Rico to visit with their public service regulatory
4	board. It was in conjunction with the Department
5	of Energy. There were other state commissioners
6	from around the country that really kind of
7	helped it's a training project to help expedite
8	the development of the Puerto Rico Energy Board.
0	There were T think they were wegentime

They were -- I think they were very receptive to the overall program. And we gave them kind of an educational perspective of what Florida is doing and how our regulatory body is structured. And I -- I know that they were very welcoming in that regard.

We got to tour PREPA. We got to tour a 60-year-old power plant. It was very interesting to see the differences on the island compared to what our utilities are doing here in Florida. And, you know, they're the second-highest cost per kilowatt hour in the country.

We also had someone who went, several time zones, from Hawaii. The chairman of the Hawaii Commission came out there to talk -- and they have the highest rates in the nation -- talk about what they were doing.

1	So it really was interesting to see where
	So, it really was interesting to see where
2	Florida is and how we can share our best practices.
3	And that could be a topic. They are really, really
4	interested in how we're structured.
5	CHAIRMAN CLARK: Great. Thank you.
6	COMMISSIONER POLMANN: What what is their
7	primary fuel source?
8	COMMISSIONER BROWN: What do you think?
9	COMMISSIONER POLMANN: Well, it's not solar.
10	COMMISSIONER BROWN: So, they have some wind.
11	They do have a few wind. They're converting some
12	of their coal plants to gas. They have legislation
13	in place that requires a certain renewable
14	percentage, expeditiously.
15	So, they have a lot of legislative goals that
16	may not, in fact, be achievable without having a
17	crazy rate undue rate impact.
18	COMMISSIONER POLMANN: So, at the old plant,
19	they probably have dials rather than digital.
20	COMMISSIONER BROWN: They they don't have
21	smart meters either.
22	(Laughter.)
23	COMMISSIONER POLMANN: Okay.
24	COMMISSIONER GRAHAM: Vacuum tubes.
25	CHAIRMAN CLARK: Other comments, other
