14	these things through session. We appreciate the
15	hard work you guys put in.
16	MR. POTTS: Thank you.

19	COMMISSIONER GRAHAM: Thank you, Mr. Chair.
20	Do we have to go through rule-making now that that
21	rule has been signed?
22	MR. POTTS: No, we do not, according to the
23	general counsel.
24	MR. HETRICK: Let me just add to that,
25	Commissioner Graham. My main goal in looking at

1	this bill, and we are going to be looking at it
2	carefully, is to ensure that all issues about
3	closing the hearing under the new law sorted out
4	prior to the hearing, so we are going to look at,
5	just as we do with voir dire and other procedures
6	in an OEP, a provision that puts everyone on notice
7	about the closure of hearing and, you know,
8	bringing that back to the Commission about that
9	procedure that we want to have in place. So
10	because we can't have surprises in mid-course
11	during a hearing.
12	COMMISSIONER GRAHAM: Don't say voir dire.
13	That wasn't nice.
14	(Laughter.)
15	MR. HETRICK: Well, we sorted that out in the
16	OEP.
17	CHAIRMAN CLARK: Commissioner LaRosa. All
18	right. Anybody else? Any other questions? Anyone
19	else? Anyone?
20	All right. Thank you for being here. We
21	stand adjourned.
