#### Discussion of Issues

**Issue 1:** Should the Commission deny Andre Trajean Fidel d/b/a Andrex Telecom, a voluntary cancellation of its CLEC Certificate No. 8406 and cancel the certificate on the Commission's own motion with an effective date of October 16, 2007?

**Recommendation:** Yes, the company should be denied a voluntary cancellation as listed on Attachment A. (Isler, McKay)

**Staff Analysis:** See attached proposed Order.

**Issue 2:** Should this docket be closed?

**Recommendation:** Staff recommends that the Order issued from this recommendation will become final and effective upon issuance of a Consummating Order, unless a person whose substantial interests are affected by the Commission's decision files a protest that identifies with specificity the issues in dispute, in the form provided by Rule 28-106.201, Florida Administrative Code, within 21 days of the issuance of the Proposed Agency Action Order. As provided by Section 120.80(13)(b), Florida Statutes, any issues not in dispute should be deemed stipulated. If the company fails to timely file a protest and to request a Section 120.57, Florida Statutes, hearing, the facts should be deemed admitted and the right to a hearing waived. If the company pays the Regulatory Assessment Fee prior to the expiration of the Proposed Agency Action Order, then the cancellation of the company's competitive local exchange telecommunications certificate will be voluntary. If the company fails to pay the Regulatory Assessment Fee prior to the expiration of the Proposed Agency Action Order, then the company's competitive local exchange telecommunications certificate should be cancelled administratively, and the collection of the past due Regulatory Assessment Fee should be referred to the Florida Department of Financial Services for further collection efforts. If the company's competitive local exchange telecommunications certificate is cancelled in accordance with the Commission's Order from this recommendation, the company should be required to immediately cease and desist providing competitive local exchange telecommunications service in Florida. This docket should be closed administratively either upon receipt of the payment of the Regulatory Assessment Fee or upon cancellation of the company's competitive local exchange telecommunications certificate. (McKay)

**Staff Analysis:** Staff recommends that the Commission take action as set forth in the foregoing staff recommendation statement.

NOTICE OF PROPOSED AGENCY ACTION ORDER  
CANCELLING COMPETITIVE LOCAL EXCHANGE TELECOMMUNICATIONS  
COMPANY CERTIFICATE ON THE COMMISSION'S OWN MOTION

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Andre Trajean Fidel d/b/a Andrex Telecom currently holds Certificate No. 8406, issued by this Commission on November 17, 2003, authorizing the provision of competitive local exchange telecommunications service (CLEC). Pursuant to Section 364.336, Florida Statutes, competitive local exchange telecommunications companies must pay a minimum annual Regulatory Assessment Fee if the certificate was active during any portion of the calendar year. Pursuant to Rule 25-4.0161(2), Florida Administrative Code, the form and applicable fees are due to the Florida Public Service Commission by January 30 of the subsequent year. Pursuant to Section 350.113(4), Florida Statutes, the Regulatory Assessment Fee return forms, for the period of January 1 through December 31, are mailed to entities at least 45 days prior to the date that payment of the fee is due. In addition, Rule 25-24.820, Florida Administrative Code, provides that a competitive local exchange telecommunications company requesting cancellation of its certificate must state its intent and date to pay the current Regulatory Assessment Fee (RAF).

On October 16, 2007, this Commission received a letter dated October 12, 2007, from Mr. Fidel requesting cancellation. The letter stated that the company stopped its operations on June 8, 2007, and closed its business. On October 30, 2007, our staff mailed the company the

2007 Regulatory Assessment Fee return form and a note advising the company must either pay the 2007 RAF or provide a date certain the fee will be paid. The company has not paid the 2007 RAF or provided a date certain the 2007 fee would be paid.

For the reasons described above, we deny Andre Trajean Fidel d/b/a Andrex Telecom's request for voluntary cancellation of its CLEC certificate. However, we find it appropriate to involuntarily cancel the competitive local exchange telecommunications certificate, effective October 16, 2007, on this Commission's own motion for failure to comply with Rule 25-24.820, Florida Administrative Code, and pursuant to Section 364.336, Florida Statutes.

Since it appears Andre Trajean Fidel d/b/a Andrex Telecom does not currently provide service in Florida and has requested cancellation of its certificate, there would be no purpose in requiring the company to pay a penalty. The cancellation of the CLEC certificate, in no way diminishes the entity's obligation to pay the applicable RAF. If this Order is not protested, the company's CLEC Certificate No. 8406 shall be cancelled, effective October 16, 2007. If the company pays the RAF prior to the expiration of the Proposed Agency Action Order, then the cancellation of the company's competitive local exchange telecommunications certificate shall be voluntary. If the company fails to protest the Order or pay the RAF prior to the expiration of the Proposed Agency Action Order, then the company's competitive local exchange telecommunications certificate shall be cancelled administratively, and the collection of the past due RAF shall be referred to the Florida Department of Financial Services for further collection efforts. If the company's competitive local exchange telecommunications certificate is cancelled in accordance with this Order, the company shall be required to immediately cease and desist providing competitive local exchange telecommunications service in Florida. This docket shall be closed administratively either upon receipt of the payment of the RAF or upon cancellation of the company's competitive local exchange telecommunications certificate. If Andre Trajean Fidel d/b/a Andrex Telecom's CLEC certificate is cancelled on this Commission's own motion and it subsequently decides to reapply for a certificate as a competitive local exchange telecommunications company, Andre Trajean Fidel d/b/a Andrex Telecom shall be required to first pay any outstanding fees, including accrued statutory late payment charges. We are vested with jurisdiction over these matters pursuant to Sections 350.113, 364.336, 364.337, and 364.285, Florida Statutes.

Based on the foregoing, it is

ORDERED that pursuant to Rule 25-24.820, Florida Administrative Code, Andre Trajean Fidel d/b/a Andrex Telecom's CLEC Certificate No. 8406 is hereby cancelled effective October 16, 2007, on this Commission's own motion for failure to pay the 2007 Regulatory Assessment Fee, pursuant to Section 364.336, Florida Statutes, and Rule 25-4.0161, Florida Administrative Code. It is further

ORDERED that the cancellation of the certificate in no way diminishes Andre Trajean Fidel d/b/a Andrex Telecom's obligation to pay the applicable Regulatory Assessment Fee. If the company's CLEC certificate is cancelled and the company subsequently decides to reapply for a certificate as a competitive local exchange telecommunications company, that company

shall be required to first pay any outstanding fees, including accrued statutory late payment charges. It is further

ORDERED that if Andre Trajean Fidel d/b/a Andrex Telecom pays the Regulatory Assessment Fee prior to the expiration of the Proposed Agency Action Order, the cancellation of the certificate shall be deemed voluntary. It is further

ORDERED that if Andre Trajean Fidel d/b/a Andrex Telecom does not pay the Regulatory Assessment Fee prior to the expiration of the Proposed Agency Action Order, the collection of the Regulatory Assessment Fee shall be referred to the Florida Department of Financial Services for further collection efforts. It is further

ORDERED that if Andre Trajean Fidel d/b/a Andrex Telecom's certificate is cancelled in accordance with this Order, Andre Trajean Fidel d/b/a Andrex Telecom shall immediately cease and desist providing competitive local exchange telecommunications service in Florida. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Office of Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings" attached hereto. It is further

ORDERED that in the event this Order becomes final, this docket shall be closed upon receipt of the Regulatory Assessment Fee, or upon cancellation of the CLEC certificate.
