At the end of the refund period, any unrefunded amount, including interest, should be remitted to the Commission by October 10, 2000, and forwarded to the Comptroller for deposit in the General Revenue Fund, pursuant to Section 364.285(1), Florida Statutes. ASC should submit a final report as required by Rule 25-4.114, Florida Administrative Code, Refunds, by October 10, 2000. If the company fails to issue the refunds in accordance with the terms of the Commission's Order, the company's certificate should be canceled, and this docket should be closed.

Issue 2: Should ASC Telecom, Inc. d/b/a AlternaTel be required to show cause why it should not pay a fine for
