The following are company-specific data. Extended Area Service (EAS) information is provided by exchange. If an optional calling plan (i.e. optional extended area service, etc.) is available, the affected exchange will be noted by being enclosed with brackets []. Also, \$0.20, \$0.25 and ECS local message rate plans are underscored. Routes available on an optional calling plan and ECS basis are shown in brackets and underscored.

In addition to the local exchange rates charged by each incumbent local exchange company (ILEC), the Federal Communications Commission (FCC) allows each ILEC to assess an interstate charge, the Subscriber Line Charge (SLC). For residential customers served by BellSouth, Frontier, or Verizon, there is one charge for the first line in a household and a separate, higher charge for additional lines. Business subscribers pay rates that distinguish according to whether they are single line or multiline customers. For the other ILECs in Florida, the same rate structure applies for business customers, but a single SLC applies to all residential lines. With the exception of the subscriber line charge for non-primary residential lines, these charges are generally subject to annual increases.

This information is current as of December 31, 2005.
