The following are company-specific data. Extended Area Service (EAS) information is provided by exchange. If an optional calling plan (i.e., optional EAS, etc.) is available, the affected exchange will be noted by being enclosed with brackets []. Also \$0.20, \$0.25, and ECS local message rate plans are underscored. Routes available on an optional calling plan and ECS basis are shown in brackets [] and are underscored.

Note: The FCC has required that a \$3.50 per month subscriber line charge apply to each residence and single-line business customer and that a \$6.00 per month subscriber line charge apply to each multi-line business access line. These charges are in addition to the rates outlines herein. FCC regulations permit the charge for each primary residential access line to increase to \$5.00 from \$3.50. Multi-line business lines can increase to \$9.00. Each company's rate may be different.
