- (8) In accordance with Section 68.065, Florida Statutes, the following charges apply to returned checks: \$25.00 charge for checks \$50.00 or less, \$30.00 charge for checks \$50.01 \$300.00, and the greater of 5% or \$40.00 for checks in excess of \$300.00.

Chapter 367.171 (7), F.S., gives the Florida Public Service Commission exclusive jurisdiction over all utility systems whose service transverses county boundaries, whether the counties involved are jurisdictional or non-jurisdictional, with certain exceptions.

Baker, DeSoto, Flagler, Glades, Indian River, and Union Counties are non-jurisdictional counties that have certain jurisdictional utilities based on the provisions of the statute.

Bradford, Clay, Jackson, Nassau, and Okaloosa Counties currently have no FPSC regulated utilities.
