Application for staff-assisted rate case in Okeechobee County by

### **Pine Ridge Management Corporation**

DOCKET NO. 110042-WS

On January 26, 2011, Pine Ridge Management Corporation (Pine Ridge) filed an application with the Florida Public Service Commission (PSC or Commission) for a staff-assisted rate case to increase its water and wastewater rates. Pine Ridge provides service to approximately 133 water and 132 wastewater customers in Okeechobee County.

### QUESTIONS & ANSWERS

## Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for Pine Ridge's rate request, the Commission staff will conduct a customer meeting to allow customer feedback about Pine Ridge and the rate-setting process. Customer comments, written and oral, will be taken into consideration when the Commission reaches a decision. One or more Commissioners may attend and participate during the meeting.

## 2 Why is Pine Ridge requesting a rate increase?

Pine Ridge is requesting a rate increase to cover increasing operating costs.

## **3** When was Pine Ridge's last approved rate increase?

This is Pine Ridge's first rate case before the Commission.

## 4 Presently, how much are the average monthly water and wastewater bills for a residential customer?

Currently, the average monthly water and wastewater bills for a residential customer are \$15.71 and \$42.89, respectively.

## **5** Using staff's proposed rates, how much would the average monthly water and wastewater bills be for a residential customer?

Under staff's proposal, the average monthly water and wastewater bills for a residential customer would be \$31.56 and \$47.87, respectively.
