Application for staff-assisted rate case in Lee County by

Useppa Island Utilities Co., Inc.

DOCKET NO. 110260-WS

On October 26, 2011, Useppa Island Utilities Co., Inc. (Useppa Island) filed an application with the Florida Public Service Commission (PSC or Commission) for a staff-assisted rate case to increase its water and wastewater rates. Useppa Island provides service to approximately 156 water and 145 wastewater customers in Lee County.

QUESTIONS & ANSWERS

Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for Useppa Island's rate request, the Commission staff will conduct a customer meeting to allow customer feedback about Useppa Island and the rate-setting process. Customer comments, written and oral, will be taken into consideration when the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

2 Why is Useppa Island requesting a rate increase?

Useppa Island is requesting a rate increase to cover increasing operating costs.

3 When was Useppa Island's last approved rate increase?

Useppa Island's last approved rate increase was in 2007.

4 Presently, how much are the average monthly water and wastewater bills for a residential customer?

Currently, the average monthly water and wastewater bills for a residential customer are \$70.42 and \$74.36, respectively.

5 Using staff's proposed rates, how much would the average monthly water and wastewater bills be for a residential customer?

Under staff's proposal, the average monthly water and wastewater bills for a residential customer would be \$78.21 and \$80.85, respectively.
