Application for increase in water rates in Marion County by

Sunshine Utilities of Central Florida, Inc.

DOCKET NO. 100048-WU

On June 1, 2011, Sunshine Utilities of Central Florida, Inc. (Sunshine) filed an application with the Florida Public Service Commission (PSC or Commission) to increase its water rates. Sunshine provides service to approximately 3,798 water customers in 23 certificated areas in Marion County.

QUESTIONS & ANSWERS

1 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for Sunshine's rate request, the Commission staff will conduct a customer meeting to allow customer feedback about Sunshine and the rate-setting process. Customer comments, written and oral, will be taken into consideration when the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

2 Why is Sunshine requesting a rate increase?

Sunshine is requesting a rate increase to cover increasing operating costs.

When was Sunshine's last approved rate increase?

Sunshine's last approved rate increase was in 1990.

4 Presently, how much is the average monthly water bill for a residential customer?


