Application for increase in water and wastewater rates in Seminole County by

Sanlando Utilities Corporation

DOCKET NO. 110257-WS

On October 31, 2011, Sanlando Utilities Corporation (Sanlando) filed an application with the Florida Public Service Commission (PSC or Commission) to increase its water and wastewater rates. Sanlando provides service to 10,163 water and 8,272 wastewater customers in Seminole County.

QUESTIONS & ANSWERS

1 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for Sanlando's rate request, the Commission staff will conduct a customer meeting to allow customer feedback about Sanlando and the rate-setting process. Customer comments, written and oral, will be taken into consideration when the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

2 Why is Sanlando requesting a rate increase?

Sanlando is requesting a rate increase to cover increasing operating costs.

When was Sanlando's last approved rate increase?

Sanlando's last approved rate increase was in 2010.

4 Presently, how much are the average monthly water and wastewater bills for a residential customer?

Currently, the average monthly water and wastewater bills for a residential customer are \$23.74 and \$28.34, respectively.

5 Using Sanlando's proposed rates, how much would the average monthly water and wastewater bills be for a residential customer?

Under Sanlando's proposal, the average monthly water and wastewater bills for a residential customer would be \$25.77 and \$35.63, respectively.


