Petition for increase in rates by

## Florida Power & Light Company

DOCKET NO. 120015-EI

On March 19, 2012, Florida Power & Light Company (FPL) filed a petition with the Florida Public Service Commission (PSC or Commission) for a base rate increase. FPL provides electric service to more than 4.5 million retail customers in all or parts of 35 Florida counties.

### QUESTIONS & ANSWERS

# Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for FPL's rate request, the Commission staff will conduct nine service hearings to allow customer feedback about FPL and the rate-setting process. Customer comments, written and oral, will be taken into consideration when the Commission reaches a decision. Commissioners will attend and participate during the hearings.

# **2** Why is FPL requesting a base rate increase?

FPL states it is requesting a base rate increase to cover increasing operating costs.

# Presently, how much is a 1,000 kwh monthly bill for residential customers?

As of January 2012, a 1,000 kwh monthly bill for residential customers is \$94.62.

# 4 Using FPL's proposed rates, how much would a 1,000 kwh monthly bill be for residential customers?

Using FPL's proposal, a 1,000 kwh monthly bill for residential customers is estimated to be \$95.19 in January 2013. That includes a base rate increase of \$5.23, however, with an estimated reduction in the cost of fuel and other changes in the bill, the net increase is \$0.57. Effective June 2013, a 1,000 kwh monthly bill for residential customers is estimated to be \$96.03. That includes a base rate increase of \$1.86, however, with an estimated reduction in the cost of fuel, the projected net increase to the bill is \$0.84 as compared to January 2013.
