Application for increase in water and wastewater rates in Lake County by

Utilities, Inc. of Pennbrooke

DOCKET NO. 120037-WS

On May 9, 2012, Utilities, Inc. of Pennbrooke (Pennbrooke) filed an application with the Florida Public Service Commission (PSC or Commission) for an increase in water and wastewater rates. Pennbrooke provides service to more than 1,360 water and 1,230 wastewater customers in Lake County.

QUESTIONS & ANSWERS

Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for Pennbrooke's rate request, the Commission staff will conduct a customer meeting to allow customer feedback about Pennbrooke and the rate-setting process. Customer comments, written and oral, will be taken into consideration when the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

2 Why is Pennbrooke requesting a rate increase?

Pennbrooke is requesting a rate increase to cover increasing operating costs.

3 When was Pennbrooke's last approved rate increase?

Pennbrooke's last approved rate increase was in 2009.

4 Presently, how much are the average monthly water and wastewater bills for customers?

Currently, the average monthly water and wastewater bills for customers are \$23.41 and \$32.05, respectively.

5 Using Pennbrooke's proposed rates, how much would the average monthly water and wastewater bills be for customers?

Under Pennbrooke's proposal, the average monthly water and wastewater bills for customers would be \$31.17 and \$39.67, respectively.
