Application for staff-assisted rate case in Brevard County by

DOCKET NO. 120078-SU

On June 6, 2012, TKCB filed an application with the Florida Public Service Commission (PSC or Commission) for a staff-assisted rate case to increase its wastewater rates. TKCB provides wastewater service to 295 customers in Brevard County.

QUESTIONS & ANSWERS

1 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for TKCB's rate request, the Commission staff will conduct a customer meeting to allow customer feedback about TKCB and the rate-setting process. Customer comments, written and oral, will be taken into consideration when the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

2 Why is TKCB requesting a rate increase?

TKCB is requesting a rate increase to cover increasing operating costs.

When was TKCB's last approved rate increase?

This is TKCB's first rate increase request before the Commission.

Presently, how much is the average monthly wastewater bill for customers?

Currently, the average monthly wastewater bill for customers is \$23.00.

5 Using staff's proposed rates, how much would the average monthly wastewater bill be for customers?

Under staff's proposal, the average monthly wastewater bill for customers would be \$25.49.


