Application for increase in water/wastewater rates in Polk County by

Cypress Lakes Utilities, Inc.

DOCKET NO. 130212-WS

On September 30, 2013, Cypress Lakes Utilities, Inc. (Cypress Lakes) filed an application with the Florida Public Service Commission (PSC or Commission) for increased water and wastewater rates. Cypress Lakes provides service to approximately 1,260 water customers and 1,160 wastewater customers in Polk County.

QUESTIONS & ANSWERS

1 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for Cypress Lakes' rate request, the Commission staff will conduct a customer meeting to allow customer feedback about Cypress Lakes and the rate-setting process. Customer comments, written and oral, will be taken into consideration before the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

2 Why is Cypress Lakes requesting a rate increase?

Placid Lakes is requesting a rate increase to cover increasing operating costs.

3 When was Cypress Lakes' last approved rate increase?

Cypress Lakes' last approved rate increase was in 2010.

4 Presently, how much is the monthly bill for customers?

The monthly water bill for water customers using 5,000 gallons per month is \$26.59. The monthly wastewater bill for customers using 5,000 gallons is \$57.66.

5 Using Cypress Lakes' proposed rates, how much would the monthly water and wastewater bill be for customers?

Under Cypress Lakes' proposed rates, the monthly water bill for customers using 5,000 gallons per month would be \$35.43 and the wastewater bill would be \$59.97

6 What if I cannot attend the customer meeting or prefer not to speak? Are there other ways to comment on this case?
